

What is REALTOR® Care Day?

REALTOR® Care Day is an annual day of service to the communities in which REALTORS® live, work and raise families.

Since its inception in 2005, REALTOR® Care Day projects have provided almost \$369,000 worth of improvements and repairs and hundreds of hours of service to local communities around central Ohio.

The RCD program is made possible by significant financial contributions combined with gifts of food, tools, services and supplies by REALTORS®, associates and local businesses.

History

Columbus REALTORS® started with one project in 2005. Last year, 484 local REALTORS®, associates, friends, family and community members worked on 23 separate projects, making over \$38,000 worth of improvements possible in a single day!

Past REALTOR® Care Day main projects have included: Mwanza Place, a 24-unit rental complex owned by the Columbus Housing Partnership (CHP) in South Linden; Indianola Homes, a CHP 12-unit rental community near the University District; American Addition (Joyce & Woodward Avenues); NoBo (North of Broad) in the King Lincoln district; Framingham Village, part of CHP's Lease Option Program; the Children's Hospital residential community, the Hilltop area, the King Lincoln District, Franklinton and the Reeb Hosack area of Columbus' South Side.

Our 2017 main project will include several residential beautification and improvement undertakings in the Hungarian Village area in Columbus' South Side.
